entered into Agreement No 367/2020 for certification and continuous supervision of the production of wood-based panels in the scope of formaldehyde emission concluded with the plant

Woodeco Grajewo sp. z o.o.

Wiórowa St. 1, 19-203 Grajewo

to acquire continuous supervision of the wood-based panels production in the scope of formaldehyde emission and carried out an independent external audit, which covered the functioning of quality control system, work of the product quality control laboratory, accuracy of the current tests of emission or content of formaldehyde in the produced wood-based panels.

Based on the results obtained (Report of qualification test № 367/PB/FC/2020), the Certification Department found that the product subjected to supervision:

**Raw particle board P2 CARB2, unfaced, glued with UF resin
in the range of thicknesses from 8,00 mm to 38,00 mm**

according to Producer statement fulfills requirements of standard:

PN-EN 312:2011 Particleboards - Specifications

the abovementioned product meets the EPA requirements for formaldehyde emission given in Final rule 40 CFR PART 770, and subject to compliance with the provisions in force in the Agreement No 367/2020 of 07.10.2020 including Appendices.
